How to get started:

- **Review the two AmeriCorps plans** offered and decide which plan option best fits the needs of your program and members
 - **Complete the Program Data Form** that will provide SRC the necessary information required to set up your program in our systems. Please fax completed Program Data Form to **803-333-1902**
 - **Complete the roster form to enroll all eligible members** and fax to the number indicated on the Roster
 - If a member elects not to enroll due to having other coverage, please have them sign the waiver form and maintain it in your file. If a member is receiving Medicare or Medicaid, they
- are to enroll, as we will pay primary. If a member has questions about their benefits, please direct them to their case worker for clarification.
 - When SRC receives the Program Data and Roster Forms, you will be assigned a six digit program number that will identify your program and members. Please use the six digit number on all forms, correspondence and communications.
 - SRC will send an Administrative Guide to the program for use as a reference. SRC will also send you member kits that you will provide to each enrolled member.
 - Tell members to use the temporary paper ID card that is provided in the member kit until they receive the plastic ID card. The ID card will be mailed directly to the member's home address and should arrive approximately four to six weeks from enrollment entry.
 - **COBRA and HIPAA** administration services are handled by SRC's in-house staff.
 - Coverage available for members only.
